Sub: Amendment of instructions regarding dearness relief to re-employed pensioners consequent on revision of ignorable part of pension for fixation of pay in the re- employment post-reg

The undersigned is directed to refer to subject cited above and to say that the grant of dearness relief to re-employed pensioners/family pensioners is presently regulated in accordance with the instructions contained in this Department's 0M No. 45/73/97-P&PW[G] dated 02.07.1999 and subsequently amended vide this Department's OM No. 38/88/2008-P&PW[G] dated 09.07.2009

- DoPT, vide their OM No.3/3/2016-Estt.(Pay II) dated 01.05.2017 have issued instructions for revision of ignorable amount of pension from Rs.4000/- to Rs. 15000/-(Rupees Fifteen Thousand) for the purpose of fixation of pay in the re-employment post. Accordingly, the amount of Rs.4000/- appearing in this Department's 0M dated 09.07.2009 is revised as Rs. 15000/- (Rupees Fifteen Thousand). The other conditions for grant of dearness relief in OM dated 02.07.1999 remain the same.
