Sub:Fixation of maximum ceiling limit for payment of Honorarium to Cashiers and other Cash & Pay Staff

Ref: Railway Board's letter No.99/AC-II/20/2/Pt. dated 25.07.2013 [RBA No.17/2013] and letter No. E[G]2013/HO1/1 dated 09.10.2013

In terms of Railway Board's above referred letter dated 25.07.2013 [RBA No. 17/2013], a ceiling limit was prescribed for payment of honorarium during a financial year to Cashiers and other Cash & Pay Staff on the Zonal Railways/Production Units. Furthermore, the aforesaid ceiling limit on payment of honorarium to Cash & Pay Staff was given effect retrospectively from 01.01.2010.

The aforesaid matter regarding prescription of ceiling limit on payment of honorarium to Cashiers and other Cash & Pay staff from a retrospective date, i.e. 01.01.2010 has been reviewed by Railway Board pursuant to directions/orders dated 02.06.2016 of Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi in OA No.1802/2014 filed by Shri U.S.Meena and others Vs. Union of India. Railway Board has accordingly decided that ceiling limit on payment of honorarium during a financial year to Cashier and other Cash & Pay staf on the Railway's as prescribed in Board's letter dated 25.07.2013 [RBA No.17/2013] would be effective from the date of issue of letter 25.07.2013 and honorarium due prior to 25.07.2013 would be sanctioned at the previous rates as effective from 01.07.2009.
